During lockdown the owner of the site decide to close the hotel side of the business due to the expected sharp downturn in the activity of the commercial traveller. Luke's first year as Golf Manager has been one he will not forget but he managed the whole operation very well in at times the most difficult circumstances.

During this Summer we had to concertina in the golf days due to the lost seven weeks which resulted in customers moving their original dates. This brought in some much needed revenue through green fees and secondary spend in the bar and restaurant. I know this caused some pressure on tee times and we have now agreed on a policy going forward which Luke has outlined in his report.

Unfortunately we are now in a second lockdown and the future once again uncertain. At the time of writing I am hoping that we will be able to reopen the course on 2^{nd} December and welcome our members back. Hopefully the same will apply for the clubhouse and the leisure facilities. Whenever we do reopen we will be doing our best to provide all our members with the best product we can.

Can I say thank you to Jim Morton for his term as club captain and to the rest of your committee for their efforts in this very difficult year, and for explaining to me some of the subtleties of a golf club and its membership which I might otherwise have missed.

Because of the Covid Rules your Members Management Committee, on which I sit, has elected to run the Annual General Meeting by Email (through the Overstone Park website) and on Facebook. Whilst not ideal I support the initiative and hope that as many members as possible take the time to read the documents, raise questions and vote on the propositions.

I hope you all manage to stay healthy and hope to see you soon.

GOLF MANAGERS REPORT

As you can imagine this year has had many ups and downs: contending with lockdown for 3 months, to reopening golf and it being as busy as it has been.

This year we have seen a decrease in society's and visitors rounds; this may come as a surprise to many of you, but the reason you may have thought we had more is because, following the lockdown, we had to reschedule golf days that were cancelled due to restrictions, and fit them into a smaller period of time. Whilst it may have looked like more golf days, our figures show otherwise.

On the other hand, we have seen members rounds increase massively. From May to September 2019 we saw 9,549 members rounds. This year we have seen that figure rise to 14,345 and consequently tee times have been harder to get than ever before.

On the shop side we have seen a decrease in sales. Needless to say, this is down to the shop being closed for a longer period of time, stock being harder to get hold of due to the high demand and the uncertainty of the current economic climate. We expect that next year we will see a rise in shop sales again.

Over the last few weeks OPL and the Committee have been looking to find ways to allow us to get more people on the golf course over the Winter months. On our return from this second lockdown the shop staff will be hot on the case of members not cancelling tee times when they are not going to play, and will be looking to join up members with members to try maximizing the slots available.

For next season OPL have made the decision not to allow visitors or golf days before 12.00 at weekends save for exceptional circumstances. I know many of our members don't agree with golf days, but they are a crucial part of our business. Nevertheless, our priority will always be the members and I am happy to talk to any of you about issues, concerns or solutions you may have.

Lastly, I would like to say thank you to all the members for respecting and honouring the rules we have set out this year and hopefully we will be back to normal soon.

TREASURERS REPORT 2019 -2020

The financial year has traditionally run from 1st January to 31st December, roughly in line with the Captains' year in office, but, because the AGM is held in the first week of December each year, this has meant that the audited Accounts could not be reported until the following December. It is now proposed that the audited financial Accounts for the year ended 31st December 2019, which were completed as normal, together with figures for the nine month period to 30th September 2020 which are in the process of being prepared, will both be available for presentation to this year's AGM.

We have two sources of income with which volunteers are able to run the Golf Section. A percentage of competition entry fees is retained to buy prizes, present awards, entertain major prize winners at Presentation Evening, and to donate the sum of £500 to the Captains' Charity each year. The second source is support funding from Overstone Park Limited, to help with the administration expenses incurred in running the Golf Section, such as Honorary Secretary stipend, printing, stationery, computer maintenance, etc.

The Accounts for the year ended 31st December 2019, audited by Norman Davis, have been displayed on the noticeboard in the Roundel since March this year. The surplus retained from the activities for the year was £143, which, when added to the funds accumulated over previous years, resulted in a Balance Sheet total of £5519.

The draft Accounts for the nine-month period to 30th September are currently with the Auditor, and are expected to be completed by 21st November. There was exceptionally high participation and positive support from the members for the competitions which were able to be held, resulting in much increased entry fees, more and higher value vouchers paid out, and also leaving a greater amount of the retained percentage mentioned earlier. On the other hand, the cancellation of Presentation Evening and a large reduction in other expenditure normally incurred in presenting awards, together with lower administration costs, has resulted in an anticipated surplus for this period in the region of £900. The audited Accounts for this period will also be displayed in the Roundel as soon as the Club re-opens, and additional copies of both sets of accounts will be available for collection.

Going forward, it is proposed that the fiscal accounting year will run from 1st October to 30th September, enabling scrutiny of the audited Accounts at least two weeks before the Annual General Meeting each year.

In the past accounts have been finalised following the change of Captains in December. This meant that we were not able to present the full accounts at the annual AGM. The Members Management Committee (MMC) following advice

from the Treasurer have agreed to change the accounting year to the end of September and the accounts presented in this years AGM represent this change.

Resolution 2. To approve the change of the accounting year.

2. Gender references in the Constitution.

Following a question by Roz Macdonald the Members Management Committee agreed to review the wording of the Constitution to make clear that the post of Club Captain is open to all genders. A draft of the proposed changes is included in the AGM package of documents for members review. Subject to any comments received from the members (and subsequent changes to the draft Constitution by the management) the proposed amendments to the Constitution will be the subject to a vote to change the Constitution.

Resolution 3. To approve the changes to the Constitution wording on genders.

3. Other changes to the Constitution.

The Management Committee also agreed to review the Constitution to consider if there was any opportunity to change the Constitution to perhaps better reflect and improve how the club and its Committees operate. Whilst draft suggestions have been discussed by the MMC the additional pressures put on all committee members as a result of the Covid 19 pandemic we propose not to table these for discussion at this AGM. Your committee will however continue to explore ideas for presentation during the 2020/2021 season.

Election of Officers

The AGM requires that members agree to the election of the Officers for the 2020 / 2021 season. The posts for election are as follows:

Club Secretary. To re-elect Chris Hoy as Club Secretary

Club Tresurer. To re-elect Averil Sutcliffe as Treasurer.

Club Captain TBC (note. Should there be no applicants the role will be carried out in accordance with the Constitution rules)

Club Vice Captain TBC

Ladies Captain Larraine Betts

Ladies Vice Captain TBC

Resolution 4. To approve the election of offices for the 2020 - 2021 year.

Accounts for the year 2019 - 2020

The Treasurer has presented the accounts for the reported period in her report.

Resolution 5. To approve the accounts for the 2019 - 2020 year

Changes to the Constitution as a result of England Golf Policy recommendations.

To protect the reputation of members and club, its vital that we are compliant and aware of any changes to the law. It is the clubs intention to follow the guidelines recommended by England Golf in this respect. The three main policies that we will seek the members approval on are:

A. Disciplinary Regulations.

Clause 9 of our Constitution calls on the Club to follow the England Golf procedures in respect of disciplinary matters. England Golf have now updated their procedures, details of which can be found at the England Golf website. The principle change is the requirement to appoint a Disciplinary Secretary as a first point of any complaint who will decide

on the most appropriate course of action. He (or she) will be empowered to either: Dismiss the complaint. Deal with the matter informally.

Refer the matter to the Disciplinary Committee.

Suggested amended wording of Clause 9 is indicated in a draft of the Constitution included in the AGM package of documents for members review.

The MMC have considered possible members who they felt would be appropriate for this role and subject to ratification by the MMC, Stephen Moore has agreed to take on the role as the first incumbent.

Resolution 6A To approve the changing of the wording of clause 9 of the Constitution to reflect England Golf guideline policy.

B. Safeguarding Regulations.

As from January 2021 it is a requirement that all affiliated clubs of England Golf agree to be bound by the "ENGLAND GOLF SAFEGUARDING REGULATIONS 2020" which can be found at the England Golf website. Overstone Park Leisure and the Golf Club's present Welfare Officer, Gina Collier, have been working hard to obtain England Golf approval to the club's safeguarding policies. At present the Constitution does not make any reference to safeguarding and for the Members Management Committee to appoint a suitably qualified Welfare Officer. The MMC are seeking approval to amend the Constitution to include a section regarding safeguarding. A draft of the suggested changes is included in the draft constitution for members review.

Resolution 6B. To approve the introduction of a clause in the Constitution to cover England Golf Safeguarding Regulations.

C. Equality and Diversity Policy.

The Equality Act 2010 provides protection from discrimination in relation to certain "Protected Characteristics", namely:

Age
Disability
Sex
Sexual Orientation
Race
Religion or Belief
Marriage and Civil Partnership
Gender Reassignment
Pregnancy and Maternity

England Golf is committed to the promotion of the Equality Act to all affiliated clubs. Our present Constitution has no references to the Act. The MMC are seeking to include a section within the Constitution to cover the act. Details of England Golf policy on Equality and Diversity can be found here. A draft of the wording is included in the draft constitution submitted to members review.

Resolution 6C. To approve to introduction of a clause in the Constitution to cover equality and diversity.
